## Introduction

---

The *DP SuperSpeed USB 3.0 2-Port PCIe* enhances your existing systems by adding two SuperSpeed USB ports to your PCIe-enabled desktop PC.

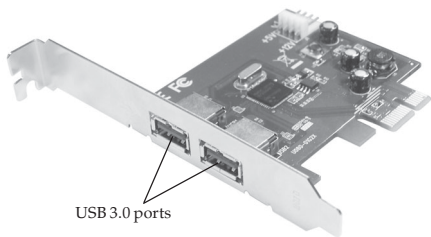

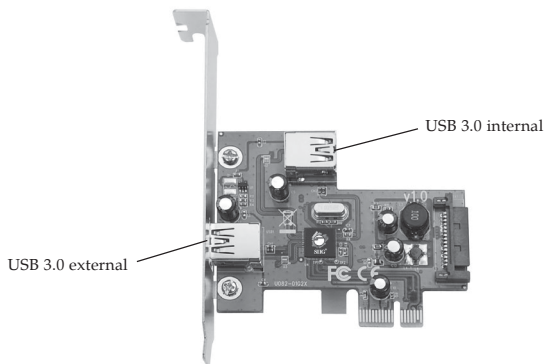

## **Hardware Installation**

---

For low profile systems, install the spare low profile bracket now.

General instructions for installing the card are provided below. Since the design of computer cases and motherboards vary, refer to your computer's reference manual for further information, if needed.

Static Electricity Discharge may permanently damage your system. Discharge any static electricity build up in your body by touching your computer's case for a few seconds. Avoid any contact with internal parts and handle cards only by their external edges.

1. Turn OFF the power to your computer and any other connected peripheral devices.
2. Unplug the power cord from the computer.
3. Remove your computer cover.
4. Remove the slot bracket from an available PCIe slot.

5. Carefully align the card's bus connector with the selected PCI Express slot on the motherboard. Push the board down firmly, but gently, until it is well seated.
6. Replace the slot bracket holding screw to secure the card.
7. Replace the computer cover and reconnect the power cord.

## **Driver Installation**

---

Please make sure the board is installed before proceeding with driver installation.

Note: For Windows 8, the driver is already embedded in the operating system. No additional driver installation steps are needed.

### **Windows 7 (32-/64-bit) / Vista (32-/64-bit) / Server 2008 R2**

1. Install the board and boot up Windows.
2. At the Windows desktop.  
*For Windows 7 / Server 2008 R2:* Go directly to step 3.

For Windows Vista: At Found New Hardware window, click **Cancel**.

3. Insert the driver CD.

For Windows 7 / Server 2008 R2: At the CD AutoPlay window, click **Open folder to view files**, then double click **Setup**.

For Windows Vista: At the CD Autoplay window, double click **Setup**.

4. At User Account Control, double click **Yes** or **Continue**. For 2008 R2, skip this step.
5. At Welcome, click **Next**.
6. Select **I accept the terms of the license agreement**, click **Next**.
7. At Ready to Install the Program, click **Install**.
8. Wait while the InstallShield Wizard configures your system. Depending on your system hardware this process may take several minutes to complete.
9. At InstallShield Wizard Complete, click **Finish**.

## Windows XP (32-/64-bit) / Server 2003 & 2008 (32-/64-bit)

1. Install the board and boot up Windows.
2. At the Found New Hardware Wizard, click **Cancel**.
3. Insert the driver CD.  
*For Windows XP/ Server 2003:* Click **Start, Run**. Type **D:\Setup.exe**, then click **OK**. (Change **D:** to match your CD\DVD-ROM drive letter)  
*For Server 2008:* At the CD Autoplay window, double click **Setup**.
4. At Welcome, click **Next**.
5. Select **I accept the terms of the license agreement**, click **Next**.
6. At Ready to Install the Program, click **Install**.
7. Wait while the InstallShield Wizard configures your system. Depending on your system hardware this process may take several minutes to complete.
8. At InstallShield Wizard Complete, click **Finish**.

## To Verify Successful Installation

1. Go to Device Manager to verify installation.  
*For Windows 8 / Windows 7 / Windows XP/ Server 2003 & 2008 R2:* Right click **Computer** or **My Computer**, click **Manage**, click **Device Manager**.  
*For Windows Vista:* Right click **Computer**, click **Manage**, click **Continue**, then click **Device Manager**.  
*For Server 2008:* Right click **Computer**, click **Manage**, double click **Diagnostics**, then click **Device Manager**.
2. Double click **Universal Serial Bus controllers**. A **USB 3.0 Host Controller** and a **USB 3.0 Root Hub** should be displayed.  
For Windows 8, a **Renesas USB 3.0 eXtensible Host Controller** should be displayed.
